Minutes of the One Hundred and Forty-second Meeting of the State Highway Commission held in the State Office Building, with the following members present:

2486. Moved by Judge Ely, seconded by Mr. Johnson, that the State Highway Engineer be directed to make a preliminary survey of a road north and south through Andrews County to determine conditions as to local material and cost of constructing a caliche base and asphalt top, and furnish said estimate to Andrews County officials for their guidance in voting a proposed bond issue.

2487. In Grayson County the matter of locating Highways #42 and #78, through the towns of Bells and Whitewright is referred to the State Highway Engineer for recommendation to the Commission.

2488. In Menard County it is agreed that the State Highway Engineer will run a new line from Menard south of the irrigated district on the nearest practical route to intersect the Arneson & Walton Survey, at approximately Station #1360, with the understanding that Menard County will secure the right-of-way on the line heretofore run on to the Mason County line. Highway #29-A)

In Presidio County, if County will vote \$450,000.00 County Bonds, the State Highway Commission agrees to match same with \$750,000.00 for improving the existing State Highways in Presidio County, and will build the highest type of road possible with funds available; Presidio County to furnish necessary right-of-way free of cost to Department, on location approved by the State Highway Engineer.

In Grayson County a State Highway is tentatively designated to be known as State Highway #116, beginning at Gunter in Grayson County, and extending in a northerly direction on the most practical route to intersect State Highway #5, about 42 miles west of Sherman, this designation being made with the understanding that it is not to be taken over for maintenance until 50% of the cost of construction and 100 ft. right-ofway has been furnished by Grayson County.

Moved by Judge Ely, seconded by Mr. Johnson, that the State Highway Department accept the tender of \$256,000.00 from Dallas County for the construction of what is known as the Scyene Road (Highway #15-A) construction to be under the supervision of the State Highway Engineer; County to furnish right-of-way not less than 100 ft. wide on location approved by the State Highway Engineer, free of cost to Department. This tender is accepted with the understanding that if \$256,000.00 is not sufficient to complete the road Dallas County will furnish the balance.

In Montague and Clay Counties the State Highway Engineer is directed to make a reasonably correct map of present location of State Highway #5, with such changes and alterations as would be practical, with a view of comparing same with the line run by Resident Engineer Dockery, from Ringgold, in Montague County, to Henrietta, in Clay County.

In Lampasas County the State Highway Department will contribute one-half of the cost of constructing Highway #108, from Lampasas to the Coryell County line, on condition that Lempasas County will furnish onehalf of such cost and right-of-way 100 ft. indwidth on location approved by the State Highway Engineer.

In Jasper County, Minute #2303, dated December 17, 1929, authorizing the construction of 4.5 miles of concrete road on Highways #45 and #63 is hereby rescinded by the Commission, and the State Highway Engineer is requested to recommend a cheaper type of construction so that all of Highway #45 may be constructed of a durable type.

In <u>Childress</u> County the Commission has seen and considered the order of the Commissioners: Court of Childress County, as passed on February 13, 1930, recorded in Vol. 5, Page 531, according to the certificate of Donna Hilliard, Deputy County Clerk, which order is as follows:

"Moved by Commissioner L. L. Foreman and seconded by Commissioner J. T. Preston that the offer verbally made by the State Highway Engineer, Gibb Gilchrist, for the routing of State Highways Nos. 4 and 5 in Childress County, as follows, be accepted:

The State Highway Commission has authorized the State Highway Engineer to propose to Childress County that the sum of \$60,000.00 here-tofore provided for the construction of State Highways Nos. 4 and 5, and being a portion of the Childress County bond issue of \$650,000.00 for the paving of these two routes through Childress County be used by Childress County for the following purposes:

1. To build a connection to the paving of which is to be the same width as that on State Highway #4, from a connection with State Highway #4 to South Main Street of Childress, such connection to be approximately 1.25 miles in length and to be built along either Avenue B or Avenue C as the Commissioners' Court of Childress County may deem best.

2. To provide for the paving of the same width as State Highway #5, will be paved through and along Cleveland Street in the town of Kirk-land, Texas, and connection thereto with State Highway #5, at both ends o Cleveland Street.

It being understood that the sum of \$60,000.00 is an estimate only but that the plans for such connections shall be approved by the State Highway Repartment and no additional obligation in excess of \$60,000.00 shall be incurred without the approval of the State Highway Commission.

The purpose of this proposal being to enable Childress County in one case to comply with an order of the Commissioners' Court made prioto the election of bonds and the other to provide ready access to State Highway #4, from south of Childress.

This resolution, however, is subject to the Highway Commission completing Highways Nos. 4 and 5 in Childress County without funds from the county additional to the \$650,000.00 bond issue voted December 21,1927.

The Clerk of the Commissioners' Court is hereby instructed to forward a certified copy of the above to the State Highway Commission at Austin, Texas, with the request that the Highway Commission pass on the above action and furnish the Commissioners' Court of Childress County a certified copy of action taken on same by the State Highway Commission."

and the agreement for the road program in Childress County is to proceed in the method provided in the above order, which is in compliance with the proposal to said County made by the State Highway Engineer under ofder of the Commission. The Highway Commission reserves the right to review the amounts paid by Childress County for right-of-way in order that it may be clearly understood at all times the amount that may be necessary for this part of the program and to give Childress County the benefit of the experience of this Department in such matters.

The order of the State Highway Commission regarding salary of resident engineer in McLennan County as passed at the December 1929 meeting is hereby rescinded. The State Highway Engineer is authorized to employ a resident engineer for McLennan County, salary to be paid not to exceed \$500.00 per month. The State Highway Engineer, in addition to work in McLennan County, is to assign to the resident engineer at Waco such additional work in other counties as may be necessary.

WHEREAS the contract of Allen Smith, of Bryan, Texas, on State Highway #3, covered by F.A.P. 506-A, Fort Bend County, has been for sometime practically completed in all respects, except a small amount of shoulder work and ditching, and

WHEREAS the said highway has been open to public use for several months, and

WHEREAS it is to the best interest of the Highway Department to do the small amount of work necessary to the total completion of said highway on its own account:

THEREFORE IT IS ORDERED that for all intents and purposes the aforesaid contract be declared complete and finalled. The State Highway Engineer is hereby directed to final the payment of said contract upon agreeing with said contractor on the amount to be deducted from the sum of said contract to cover the small amount of work hereinbefore referred to.

In Travis County a State Highway is hereby designated beginning at the corner of Sixth and Onion Streets and extending north through the State Cemetery grounds to an intersection with Eleventh Street. road through State property will be known as Lou Kemp Avenue in recognition of services to the State of Texas of Mr. Lou Kemp in spending time, money and effort in moving to the State Cemetery the bodies of famous Texas statesmen and soldiers. This road is designated and will be constructed to provide the people of Texas access to the cemetery that is not now available. An appropriation of \$7,000.00 is hereby made to cover the cost of the construction of this road with gravel and asphalt topping. construction of this road the State Highway Engineer is directed to provid a bronze plate stating the conditions of this designation, how it was made and for whom. The State Highway Engineer is also directed to request the City of Austin to rename Onion Street from the cemetery grounds south, the same as the name of this road. A.F.E. 30-115.

Motion by Judge Ely, seconded by Mr. Johnson, that an allotment of funds in the amount of \$15,000.00 be made for preliminary engineering appropriation on Highways #14, and #34, in Ellis County. On Highway #14, from a point 7.25 miles south of the Ellis-Dallas County line to the Ellis-Navarro County line, a distance of approximately 16.6 miles; on Highway #34, from the town of Reagan Springs (8 miles west of Ennis) to the Trinit River, or Ellis-Kaufman County line, a distance of 20.5 miles. This appropriation is made in order that surveys may be completed and plans prepared A.F.E. 30-116.

The Commission has received and considered the proposal under date of February 24th, 1930, from Joseph W. Bailey, Jr. and Randolph Bryant, Attorneys for the Red River Bridge Company, proposing to sell the Red River Bridge to the States of Texas and Oklahoma, for the sum of \$116,000.00 to be paid at once, and with the further condition that the bridge company will be permitted to collect the old rate of toll for a period of two years from the date of the payment of the sum referred to above.

The State Highway Department of Texas having endeavored to secure from the Red River Bridge Company, prior to the award of contract for construction of a new bridge, a proposal to sell this structure: for a sum figure of approximately the replacement falue of said structure:, and said company having declined, under date of November 2, 1929, to consider such a sale, and the further fact that the proposal of February 24, 1930, is in effect, the payment of \$116,000.00 to the Red River Bridge Company after the new bridge has been completed and would be of little or no value to the State of Texas, the proposal made under date of February 24, 1930, by the Red River Bridge Company, through its attorneys, is hereby declined.

The State Highway Engineer is instructed to complete the surveys in the Davis Mountains as provided in Chapter #37 of the First Call Session of the 40th Legislature.

2611. The following policy will apply in the future on appointments of Resident Engineers:

For Resident Engineers handling one county only the maximum salary of \$350.00 per month shall be as heretofore provided.

For Resident Engineers handling two or more counties the maximum salary shall be \$500.00 per month.

The appointment of Resident Engineers on this plan is to be made by the State Highway Engineer and submitted to the Commission for comfirmation at the first meeting following the appointment. Any proposed employment with salary in excess of \$500.00 per month shall be submitted to the Commission for action before being made.

In regard to a Resident Engineer of the State Highway Department supervising lateral road work on request of the county and being paid direct by the county, this may be authorized by the State Highway Enginee provided the total salary to be paid by the State Highway Department and the county for such resident engineer shall not exceed \$500.00 per month except by special order of the Commission, and provided further that the supervision of the county work is not to interfere with the work of the Department.

The appointment of Mr. D. L. Hogan to Resident Engineer for the State Highway Department at Tyler, Texas, to handle the \$2,000,000.00 Yan Zandt County program, the work on State Highway #37 in Smith and Wood Counties, the work on the north end of Highway #37 in Cherokee Count, and such other work in adjoining counties as the State Highway Engineer may direct, the salary to be paid being \$500.00 per month, is hereby approved.

In Motley County on bids received February 25, 1930, contract for grading and small drainage structures from Matador to Cottle County line a distance of 18.375 miles, on State Highway #28, F.A.P. 529-A, is awarded to C. H. McClellan, Wichita Falls, Texas, for \$83,939.70, which is the lowest and best bid.

In Guadalupe County on bids received February 24, 1930, contract for grading and small drainage structures from one-half mile east of Kingsbury to San Marcos River, a distance of 7.306 miles, on State Highway #3-A, F.A.P. 521-A & B, is awarded to R. B. Sparks, Dallas, Texas, for \$56,884.90, which is the lowest and best bid.

In <u>Guadalupe</u> County on bids received February 24, 1930, contract for large drainage structures from Seguin northeast to one-half mile east of Kingsbury, a distance of 7.306 miles, on State Highway #3-A, F.A.P. 521 A & B, is awarded to Bart Moore, San Antonio, Texas, for \$34,596.35, which is the lowest and best bid.

In <u>Culberson</u> and <u>Hudspeth</u> Counties on bids received February 25, 1930, contract for large structures from Van Horn west to Carrizo Divide a distance of 8.835 miles, on State Highway #1, F.A.P. 558-B & C, is awarded to George W. Orr, El Paso, Texas, for \$19,813.36, which is the lowest and best bid.

In <u>Culberson</u> and <u>Hudspeth</u> Counties on bids received February 25, 1930, contract for grading and drainage structures from Van Horn west to Carrizo Divide, a distance of 8.835 miles on State Highway #1, F.A.P. 558-B & C, is awarded to Ralls & Wright, El Paso, Texas, for \$90,653.06, which is the lowest and best bid.

In Cooke County an inspection having been made by the Engineers of the Bureau of Public Roads, and the Engineers of this Department, on the route proposed from the end of the bridge location selected by the State of Oklahoma, and it having been found that it will require a 6% grade, and in addition a distance of 3400 feet to the top of the hill, with an additional height to the structures, and it also having been found that a more suitable location may be found on either side of said proposed bridge site, and further it having been represented to this Commission, that Oklahoma prefers that if the route they selected cannot be used, that the Route C, just down stream from the Santa Fe, which provides a route up the Santa Fe Canyon be used. The Commission would be inclined to favor Oklahoma's request for the bridge site were it not for the fact that it is feared that the grade which will be provided on the Texas side makes it impractical for south bound traffic with heavy loads, and that the freedom of the bridge on this location would not be entirely consummated. The State Highway Commission of Texas hereby proposes to the State Highway Commission of Oklahoma that "Line C" be adopted and that the bridge projec be extended from high ground on the Oklahoma side to high ground on the Texas side, and that the cost of such construction be divided equally. If this proposal is accepted by Oklahoma, an appropriation of \$60,000.00 is hereby made to cover the cost of grading and drainage from the Red River to intersection of Highway #5, at or near Gainesville.

In <u>Victoria</u> County, came on to be considered the question of award of contract for construction of concrete pavement on Highway #12, and it having been found that the order approved by the Commission on May 24, 1929, awarding contract for Project F.A.P. 543-D was not put of record, it is hereby ordered that this be done:

"In Victoria County on bids received May 24, 1929, contract for construction of concrete pavement on Highway #12, F.A.P. 543-D, from Jackson County line to Victoria, a distance of 15.099 miles, is awarded to Dodds and Wedegartner, San Benito, Texas, for \$291,261.07, which is the lowest and best bid."

In <u>Jackson</u> County, came on to be considered the question of award of contract for construction of concrete pavement on Highway #12, and it having been found that the order approved by the Commission on May 24, 1929, awarding contract for Project 518-J and 543-A, was not put of record to the hereby ordered that this be done:

"In Jackson County on bids received May 24, 1929, contract for construction of concrete pavement on Highway #12, from Wharton County line to Idna, a distance of 11.880 miles, is awarded to Dodds and Wedegartner, San Benito, Texas, for \$236,218.40, which is the lowest and best bid."
