Minutes of the One Hundred and Forty-third Meeting of the State Highway Commission held in the State Office Building, with the following members present:

R. S. Sterling, Chairman, Cone Johnson, Member. W. R. Ely, Member, Gibb Gilchrist, State Highway Engineer.

2621. In Andrews County, if County will furnish \$200,000.00 for the construction of a highway from the Ector County line to the Gaines County line, the State Highway Department will furnish balance of money necessary for completion of road, on condition that that part of the highway in Andrews County from the town of Andrews to the Gaines County line will not be constructed until Gaines County has provided fifty percent of the cost of constructing the road from the Andrews County line to Seminole, in Gaines County. Conditioned further that in addition to the \$200,000.00 Andrews County will furnish right-of-way not less than 100 ft. in width on location approved by the State Highway Engineer.

In Winkler and Loving Counties the State Highway Engineer is directed to make location on most direct and practical route from the vicinity of Kermit and Wink, in Winkler County, west to a point in Loving County, near the village of Ramsey, on condition that Winkler and Loving Counties will pay the expense of making the location for a county road connecting Highways Nos. 82 and 17.

In Houston County it is ordered by the Commission that the sum of \$2,206.00 be released to the Grapeland District out of the District's portion of cost of improving State Highway #19 through said district for the purpose of enabling the District to secure the necessary right-of-way on route approved by the State Highway Engineer; this with the understanding that if Houston County's pending bond issue carries and the Grape land District bonds are taken up by the county issue, then the Grapeland district will refund to the Highway Commission the amount released for the purpose of securing the right-of-way. In Upton County on bids received March 17, 1930, contract for construction of grading and small drainage structures from Crane County line to Rankin, a distance of 22.954 miles, on State Highway #99, S.P. 903 F & , is awarded to Armstrong & Hudman, Pecos, Texas, for \$64,533.30, and the contract for the large structures is awarded to W. W. Vann, Mercedes, Tex, for \$56,880.10, which are the lowest and best bids.

In Mason County on bids received March 17, 1930, contract for construction of reinforced concrete and steel bridge and embankment approaches across Llano River on State Highway #9, S.P. 911, is awarded to Monarch Engineering Company, San Antonio, Texas, for \$117,749,14, which is the owest and best bid.

2626.

In <u>Hood</u> and <u>Parker</u> Counties it is ordered by the Commission that the application of said counties for extension of Highway #122 from Cresson, in Hood County, to Weatherford, in Parker County, be granted on condition that Parker and Hood Counties shall furnish not less than 100 ft. right—of—way on location approved by the State Highway Engineer, and on the further condition that the highway will not be taken over for maintenance until said counties furnish fifty percent of the cost of constructing same, and construction has been completed.

In <u>Johnson</u> County it is ordered by the Commission that the application for designation of a State Highway from Clehurne to Grandview be denied.

2628.

In Montague County the State Highway Engineer is directed to make investigation and report to the Commission on the advisability of reconstructing the overpasses on Highways 2 and 50, west of the town of Bowie, taking into consideration the probable permanency of location and cost.

26281.

In <u>Montague</u> County when the town of Bowie is ready to pave its principal street connecting Highways 2 and 50, the State Highway Department will join with said town of Bowie to the extent of two-thirds of the cost of an 18 ft. pavement on that part of said highway to a point where, under the Federal law and the rules of the Department, the State can participate; and in the event the City of Bowie does not decide to construct a concrete or other durable type of pavement to their city limits, then it is the order of the Commission that the State Highway Engineer proceed with the improvement of the street up to point where houses average less than 200 feet apart, with an asphalt top, 18 ft. wide.

In Tyler County in regard to County's proposal to vote a bond issue of \$300,000.00 for the construction of all present designated State Highways in said county the State Highway Engineer is instructed to inform the County Officials that if they will vote \$300,000.00 for the improvement of their highways, which sum is practically up to the constitutional limit of taxation for this purpose, the State Highway Commission will take said \$300,000.00, supplement it with funds of their own, not less than in the proportion of two to one, and will undertake to improve all present dasignated highways, to-wit, Highways 40, 45 and approximately five miles of State Highway #106, of most durable and practical type; but if it is found that it will require more than two to one State Funds then the construction is limited to not more than \$16,000.00 per mile.

In <u>DeWitt</u> County the State Highway Engineer is directed to proceed with pland and specifications for the construction of Unit II on any part of Highway #119 and #72, that is ready for such construction, on condition that DeWitt County, first and last, will pay fifty percent of the cost of the completed road.

In <u>DeWitt</u> County proposal having been made by County Officials to turn over to the State Highway Department a paved road, approximately 12 miles in length, from Yorktown to the Karnes County line, in the direction of Nixon, the State Highway Engineer is directed to investigate and report to the Commission his recommendation as to what action should be taken.

In San Jacinto County the State Highway Engineer is directed to prepare plans and specifications for the construction of grading and drainage structures on Highway #45 from Walker County line to Point Blank.

In Gillespie County on bids received March 18, 1930, contract for construction of grading and small drainage structures from Fredericksburg west 12.720 miles, on State Highway #20-A, S.P. 908-C, is awarded to Brown & Root, Austin, Texas, for \$84,742.66, and the contract for the large structures is awarded to Cage Bros. Bishop, Texas, for \$79,817.28, which are the lowest and best bids.

In Bowle County on bids received March 18, 1930, contract for construction of grading and small drainage structures from DeKalb south 13.271 miles on State Highway #11, S.P. 922-F, is awarded to C. W. Burgess, New Boston, Texas, for \$58,243.11, and the contract for the large structures is awarded to C. W. Burgess, New Boston, Texas, for \$21,502.49 which are the lowest and best bids.

In Crane County on bids received March 18, 1930, contract for con-2635. struction of grading and small drainage structures and triple bituminous surface treatment on caliche base course from Ector County line through Crane County to the Upton County line, a distance of 32.355 miles, on State Highway #137, S.P. 909-B, is awarded to L. W. Pelphrey, Breckenridg Texas, for \$424,694.77 and the contract for the large structures is award to J. W. Gwin, Birmingham, Ala., for \$25,155.52, which are the lowest and best bids.

2636. In Caldwell County on bids received March 18, 1930, contract for construction of grading and small drainage structures from Hays County line south to Fentress, and grading and small drainage structures and standard gravel surface course on Martindale connection, a distance of 12.227 miles, on State Highway #80, S.P. 849-A, is awarded to Standifer Bros., Big Wells, Texas, for \$60,553.36, and the contract for the large structures is awarded to Dozier Construction Company, Austin, Texas, for \$41,718.44, which are the lowest and best bids.

In Brown County on bids received March 18, 1930, contract for construction of grading and small drainage structures from end of S.P. 896-A north to the Eastland County line, a distance of 14.707 miles, on State Highway #129, S.P. 896-B, is awarded to Carey Bros., Anson, Texas, for \$60,065.16, and the contract for the large structures is awarded to G. F. Davis, Abilene, Texas, for \$32,027.32, which are the lowest and best bids

2638. It is ordered by the Commission, upon the recommendation of the Stage Highway Engineer, that all bids received March 18, 1930, for construction of grading and drainage structures on Highway #106, S.P. 890-C, in Tyler County, be rejected and readvertised at a later date, as bids received at this time are not within money available.

In Val Verde County on bids received March 18, 1930, contract for limestone rock asphalt surface treatment from five miles north of Del Rio north a distance of 4.48 miles, on State Highway #30, Job M-15-E-2, is awarded to Houston Surfacing Company, Houston, Texas, for \$9,289.90, which is the lowest and best bid.

F. Connelly Paving Company Little Rock, Arkansas, for \$9,774.06, which is the lowest and best bid.

Im Red River County on bids received March 18, 1930, contract for double bituminous surface treatment from three miles west of Clarksville to a point three miles west of Bagwell, a distance of 6.5 miles, on State Highway #5, Job M-1-H-4, is awarded to P. F. Connelly Paving Company, Little Rock, Arkansas, for \$13,171.60, which is the lowest and best bid.

In Potter County on bids received March 18, 1930, contract for single bituminous surface treatment from Amarillo to Carson County line, a distance of 11.31 miles, on State Highway #33, Job M-4-D-2, is awarded to Maney & Alley, Oklahoma City, Okla., for \$16,941.60, which is the lowest and best bid.

In Sutton County on bids received March 18, 1930, contract for double bituminous surface treatment from Sonora to Edwards County line, a distance of 22.3 miles, on State Highway #30, Job M-7-B-2, is awarded to Dexter Construction Company, Dallas, Texas, for \$40,791.66, which is the lowest and best bid.

2646. In Gonzales County on bids received March 18, 1930, contract for single bituminous surface treatment from 5.7 miles north of Gonzales-DeWitt County line to $2\frac{1}{2}$ miles south of Gonzales, a distance of 7.2 miles on State Highway #29, Job M-13-A-3, is awarded to McKinney & Parmley, Nacogdoches, Texas, for \$9,364.32, which is the lowest and best bid.

P. Turner, Marshall, Texas, for \$73,637.59, which is the lowest and best bid.

In Edwards County on bids received March 18, 1930, contract for single bituminous surface treatment from Rock Springs east a distance of 9.22 miles, on State Highway #55, Job M-15-A-3, is awarded to Dexter Construction Company, Dallas, Texas, for \$12,337.66, which is the lowest and best bid.

In Collin County on bids received March 18, 1930, contract for double bituminous surface treatment from Collin-Hunt County line west to junction with Highway #78, a distance of 4.15 miles, on State Highway #39 Job M-18-N, is awarded to Dexter Construction Company, Dallas, Texas, for \$8,355.08, which is the lowest and best bid.

Enterprise, a distance of 4.41 miles, on State Highway #26, Job M-10-I-4, is awarded to N. P. Turner, Marshall, Texas, for \$11,234.89, which is the lowest and best bid.

In Harrison County on bids received March 18, 1930, contract for double bituminous surface treatment from Marshall north to Marion Co. line a distance of 11.74 miles, on State Highway #8, Job M-10-K-4, is awarded to Flenniken Construction Company, Shreveport, Louisiana, for \$26,556.00 which is the lowest and best bid.

2655. In Llano County on bids received March 18, 1930, contract for grading and drainage structures on short section of Highway #124, Job M-14-G-3, a net distance of 1.496 miles, is awarded to C. W. Gilfillin, Austin, Texas, for \$23,456.78, which is the lowest and best bid.

In Wood County on bids received March 18, 1930, contract for grading and small drainage structures from Winnsboro to a point 10 miles south of Winnsboro, a distance of 9.748 miles, on State Highway #37, Mob M-10-G-2 is awarded to E. G. Powell, Jacksonville, Texas, for \$36,852.54, which is the lowest and best bid.

In Eastland County on bids received March 18, 1930, contract for double bituminous surface treatment from Eastland to Carbon, a distance of 9.09 miles, on State Highway #67, Job M-8-K-2, is awarded to McClung Construction Company, Fort Worth, Texas, for \$17,762.14, which is the lowest and best bid.

It is ordered by the Highway Commission that payment of \$418.35 be made to Raymond Canion, Contractor for suffacing on S.P. 567, in Marion County, on Highway #49, between Jefferson and the State line, on account of the fact that he was required to move more material from the subgrade than was shown on the plans, and no payment for this work was made in the final estimate. The Resident Engineer estimates that 2,789 cubic yards of material was moved from the subgrade in excess of that called for on the plans, and this payment is for moving this material at a unit price of 15¢ per cubic yard. In Bowie County an initial appropriation of \$45,522.21 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #11, S.P. 922#F from DeKalb south a distance of 13,271 miles, for the construction of grading and drainage structures, on condition that said county will furnis \$45,522.20 for such improvement and such right-of-way as may be required to be not less than 100 ft. in width, fencing to be done by the County; and with the further understanding that should the cost of improvement exceed the foregoing estimate Bowie County shall furnish its proportionate share of the additional cost which is 50%. In <u>Bowie</u> County an initial appropriation of \$3,238.33 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #5, S.P.579-A from the beginning of F.A.P. 480-A to North Front Street, a distance of 0.129 miles in the town of New Boston for the construction of grading and concrete pavement on condition that said county will furnish such right-of-way as may be required, fencing to be done by the County. In <u>Titus</u> County in the matter of engineering fees due Chas. Chappel Engineer of Titus County, Job 32-B, Project F.A.P. 333-B.

It is ordered by the Commission that Chas. Chappell, on the order of Titus County, be paid \$1,362.29, balance due on said engineering fees, same to be in full payment of such fees; and

WHEREAS, a warrant was drawn in favor of Camp County by mistake, for this purpose, which warrant was delivered to Camp County and by it appropriated;

THEREFORE, whatever claim Titus County may have against Camp County be and the same is hereby relinquished and transferred to the Highway Department. A.F.E. 30-121.

In <u>Titus</u> County an initial appropriation of \$30,000.00 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #65, S.P.938 from Mount Pleasant to Cotton Belt Railroad, a distance of 0.352 miles, for the construction of an underpass, on condition that said county will furnish such right-of-way as may be required to be not less than 100 ft. in width, fencing to be done by the County and the Cotton Belt Railroad Company will pay \$10,000.00 toward cost of project. In <u>Titus</u> County an initial appropriation of \$12,000.00 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #49, S.P.227 Reop. from Mount Pleasant south a distance of 1.539 miles, for the construction of relocation of Highway #49, to conform to the location of Underpass to be built on Highway #65, on condition that said county will furnish such right-of-way as may be required to be not less than 100 ft. in width, fencing to be done by the County. A.F.E. 30-123.

In Cass County on application received October 1929, the Highway Commission makes the following order:

That State Highway #77 be extended from Douglasville to Atlanta and be taken over for maintenance on the following conditions, that the proposal of Cass County to furnish \$1,500.00 for the maintenance of this road to March 1931 be accepted, and the State Highway Engineer is directed to have this money placed in escrow, and on the further condition that Cass County will within two years from this date provide funds in the amount of 50% of the cost of construction in addition to a right-of-way not less than 100 ft. wide for the construction of this road, and in the event thes funds are not provided prior to March 1, 1931, Cass County will furnish \$100.00 per mile for the maintenance of this road from March 1, 1931, to March 1, 1932. If then the County shall not have provided funds in the amount of 50% of the cost of construction in addition to a 100 ft. rightof-way, based on estimates made by this Department, said designation shall on that date be automatically cancelled and maintenance withdrawn. State Highway Engineer is instructed to put this order into effect when cass County puts in escrow the \$1,500.00, and the County agrees to pay in 1931 \$100.00 per mile for the second year.

In Red River County an initial appropriation of \$7,236.00 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Maintenance Division on State Highway #66, from intersection of Highway #5 to Whiterock, a distance of 1.85 miles; this appropriation being made for betterment work, Job M-1-K-4, for resurfacing with gravel in order to place this section of road in as good condition as it was in when turned over to the State. This appropriation is made without right-of-way requirements on condition that when this improvement is made this highway is to be dropped from the System. A.F.E. 30-124.

The authorization for the construction of Unit I, State Highway #23 from Vernon north to the Red River, Wilbarger County to advance 100% of the cost of construction of Unit I, is made with the distinct understanding that the State Highway Department will not contribute any funds for the construction of Units I or II on this highway until a free bridge has been provided over the Red River.

In Young County an initial appropriation of \$2,000.00 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Maintenance Division on detour for State Highway #67 from South Bend to Young-Stephens County line, a distance of 4 miles; this appropriation being made for betterment work, Job M-3-N for regraveling county road being used for detour. In Throckmorton County an increase appropriation of \$15,497.20 State and Federal Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #23, F.A.P. 544-B-II from Throckmorton to Shackelford County line, a distance of 15.827 miles, for the construction of concrete pavement, on condition that said county will furnish \$7,748.60 for such improvement. In Lubbock County an initial appropriation of \$272,965.26 State and Federal Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #7, F.A.P. 502-A-II, from Lubbock to Slaton, a distance of 14.952 miles, for the construction of concrete pavement, on condition that said county will furnish one-third cost of completed road for such improvement, and such right-of-way as may be required, fencing to be done by the County. In El Paso County an initial appropriation of \$63,062.30 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Maintenance Division on State Highway #130, from one mile east of El Paso to the Hudspeth County line, a distance of 25.724 niles; this appropriation being made for betterment work, Job M-6-N-2, for single bituminous surface treatment. No right-of-way requirements as 100 feet right-of-way was secured when constructed. This appropriation is to be reduced by such an amount as the El Paso-Hudspeth Road District has remaining for this road, it being understood that all these funds are to be applied to same. A.F.E. 30-128.

In Hudspeth County an initial appropriation of \$35,039.40 State Funcs is hereby made to be expended under the direction of the State Highway Engineer through the Maintenance Division on State Highway #130, from Hudspeth-El Paso County line east a distance of 14.292 miles, this appropriation being made for betterment work, Job M.6-V-2 for single bituminous surface treatment. This appropriation is made without right-of-way requirements as 100 feet right-of-way was obtained when constructed. The above appropriation is to be reduced by such an amount as the El Paso-Hudspeth Road District has remaining for this road, it being understood that all these funds are to be applied to same. A.F.E. 30-129.

In <u>Crane</u> County an initial appropriation of \$293,382.73 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #137, S.P. 909-B, from the Ector County line through Crane to the Upton County line, a distance of 32.355 miles, for the construction of grading and drainage structures and triple bituminous surface treatment on caliche base course on condition that said county will furnish \$293,382.72 for such improvement, and such right-of-way as may be required to be not less than 100 ft in width, fencing to be done by the County; and with the further understanding that should the cost of improvement exceed the foregoing estimat Crane County shall furnish its proportionate share of the additional cost which is 50%. A.F.E. 30-130.

It is ordered by the Commission that a State Highway be designated from a point on Highway #27, at or near the town of Ozona in Crockett County, to a point on Highway #99, in <u>Irion</u> County, to or near the town of Barnhart. This designation is conditioned upon the counties furnishing the required right-of-way and their pro rata share of the cost of the construction of this highway.

In Runnels County an initial appropriation of \$41,534.16 State and Federal Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #4, F.A.P. 590-A, from Ballinger to the Concho County line, a distance of 10.988 miles, for the construction of grading and drainage structures on condition that said county will furnish \$20,767.08 for such improvement and such right-of-way as may be required to be not less than 100 ft. in width, except within the city limits of Ballinger where the minimum right-of-way width shall be 80 ft., fencing to be done by the County; and with the further understanding that should the cost of improvement exceed the foregoing estimate, Runnels County shall furnish its proportionate share of the additional cost which is 33-1/3%. A.F.E. 30-131.

In <u>Mason</u> County an initial appropriation of \$109,234.61 State Munds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #9, S.P. 911, from Sta. 533/34.2 to Sta. 567/41.33, a distance of 0.987 miles, for the construction of Llano River bridge and approaches, on condition that said county will furnish \$36,411.54 for such improvement and such right-of-way as may be required to be not less than 100 ft. in width, fencing to be done by the County; and with the further understanding that should the cost of improvement exceed the foregoing estimate Mason County shall furnish its proportionate share of the additional cost. In <u>Taylor</u> County an initial appropriation of \$29,649.02 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Maintenance Tivision on State Highway #1, from Abiler to Nolan County line, a distance of 23.367 miles; this appropriation being made for betterment work Job M-8-E-3 for reshouldering from Abilene to Nolan County line. This appropriation is made without right-of-way requirements as 100 feet right-of-way has already been furnished.
