Minutes of the One Hundred and Forty-eighth Meeting of the State Highway Commission held in the State Office Building, with the following members present:

3201.

In <u>Jeff Davis</u> County, in compliance with the provisions of Chap. 37, of the Acts of the First Called Session of the Fortieth Legislature, there is hereby ordered to be improved as a part of the system of State Highways, a highway to be known as The Davis Mountains State Park Highway, to traverse the course and territory as set forth in said Chap. 37, in accordance with the survey of said highway heretofore made by this Commission; said highway right-df-way to have the width of 100 feet.

Commission; said highway right-of-way to have the width of 100 feet.

This order shall be effective only upon the immediate conveyance to the State of an easement granting the unconditional right-of-way for said highway, of the width herein prescribed, along the route provided by said survey; and also upon the donations to the State of tracts of land abutting on said highway sufficient in extent and satisfactorily located, in the judgment of the State Highway Commission or its duly authorized representative, for the use of the people of Texas for camping accommodations and for park purposes, so long as such lands shall be devoted to such use.

The State Highway Engineer is authorized, in accordance with the provisions of said Chap. 37, to utilize State convicts in the construction of said highway, if satisfactory arrangements to that end can be arrived at with the State Prison Board, it being the opinion of the State Highway Commission that the use of convicts in constructing this partimecular road is practicable and will reduce the cost of construction.

It is further the order of the Commission that D. E. Colp of San Antonio, Texas, Chairman of the Texas State Park Board, be appointed to communicate with the adjacent landowners and report to the Commission the tracts of land available for park sites.

3202.

In <u>Cameron</u> County the Commission proposes to designate as a part of State Highway #4, or a portion of what is known as the Old Military Road leading into Brownsvible. The point of intersection with the present State Highway #12 or #12-B through Hidalgo County is not known and will be determined on future developments. The purpose of this order is to announce the intention of the Commission and to provide for 1931 comstruction of the present gaps in this highway in Cameron County.

The State Highway Commission will pay as expenditures in 1931, 50% of the cost of paving these two gaps in this road between Brownsville and the Hidalgo County line, the County, in addition to furnish not less than 100 ft. right-of-way on the old improvement as well as the new.

The State Highway Engineer will take the matter up with the Commissioners: Court of Hidalgo County, looking toward the final solution of the route through said county, and the cooperation of said county in using as a temporary connection the improved road in Hidalgo County leading south from Mercedes; also to take matter up with the Commissioners! Court of Cameron County in case the temporary route is by way of LaFeria.

3203.

In <u>Cameron</u> County the State Highway Engineer is authorized to proceed with plans and specifications for the improvement of State Highway #4, from the City limits of Harlingen to the Arroyo Colorado Bridge, conditioned that arrangements can be made by which the financing of this project can be advanced by the county to the State on satisfactory terms; conditioned further that Cameron County is to furnish satisfactory right of way.

3204.

In San Saba County it is ordered by the Commission that the State Highway Department will pay two-thirds of a 20 ft. strip on that part of paving proposed by the City of San Saba traversed by State Highways, on condition that thereafter the State Highway Department will be relieved of maintenance on section of the streets paved and that the City of San Saba will agree to enforce parallel parking where deemed necessary, and on the further condition that the City of San Saba will extend the pavement so as to make the paved street 36 feet in width. In <u>Caldwell</u> County on bids received July 30, 1930, contract for construction of 1-120 ft. steel truss span, 38-28 -6" concrete girder spans, 22 ft. roadway, concrete caisson type piers, concrete pile bents, U-type abutments and embankment approaches over Plum Creek, a distance of 0.484 miles, on State Highway #3-A, F.A.P. 522-B, is awarded to Grant Williams, Oklahoma City, Okla., for \$108,820.14, which is the lowest and best bid. (Approved by the Federal Department August 18, 1930).

In <u>Haskell</u> County on bids received July 31, 1930, contract for construction of grading and small drainage structures from Highway #30 to the Stonewall County line, a distance of 13.834 miles, on State Highway #18, F.A.P. 587-A, is awarded to Womack-Henning & Rollins, Sherman, Tex, for \$39,119.68; and the contract for the large structures is awarded to L. D. Parks, Newcastle, Texas, for \$18,947.62, which are the lowest and best bids. (Approved by the Federal Department August 21, 1930).

In <u>Caldwell</u> County on bids received July 30, 1930, contract for construction of grading and drainage structures from Luling to the Gonzales County line, a distance of 6.073 miles, on State Highway #3-A, F.A.P. 522-A, is awarded to Standifer Bros, Big Wells, Texas, for \$65,396.79, which is the lowest and best bid. (Approved by the Federal Department September 2, 1930)

In Aransas County on bids received September 15, 1930, contract for construction of two timber pile trestle bridges using southern pine material, with concrete floor 704.5 ft. and 799.5 ft. respectively ever Cavasso Creek and Salt Creek between Lamar and Refugio County line, a distance of 0.284 miles, on State Highway #57, S.P. 790-C, is awarded to Cage Construction Company, Taft, Texas, for \$42,213.21, which is the lowest and best bid.

In <u>Upton</u> County on bids received Sept. 15, 1930, contract for construction of grading and drainage structures from Rankin to Reagan County line, a distance of 10.471 miles, on State Highway #99, S.P. 903-H is awarded to White Bros. Construction Company, San Angelo, Texas, for \$34,834.18, which is the lowest and best bid.

In <u>Navarro</u> County on bids received September 15, 1930, contfact for construction of concrete pavement from the north end of County Highway #1-A, to Corsicana, a distance of 3.783 miles on StateHighway #22, S.P. 902-A, Unit II, is awarded to F.P. McElwrath, Corsicana, Texas, for 80,499.37, which is the lowest and best bid.

In Culberson County on bids received September 15, 1930, contract for construction of grading and small drainage structures from Van Horn to a point 13.021 miles east on State Highway #1, F.A.P. 557-D, is awarded to Gifford Hill & Company, Dallas, Texas, for \$53,387.91; and the contract for the large structures is awarded to Gifford Hill & Company, for \$35,332.14, which are the lowest and best bids.

3212-A Moved by Judge Ely, seconded by Mr. Johnson that the order of the Highway Commission cancelling Highway #109, from Flatonia, in Fayette County, to Smithville, in Bastrop County, at the August meeting of the Commission be rescinded, with the understanding that the road is not to be taken over for maintenance by the State until finally completed and that the question of location of said road into the town of Flatonia be referred to the State Highway Engineer. The State Highway Engineer is further authorized to make location of said road from Flatonia to Smithville on condition that the counties affected will pay the entire cost of such survey.

In Panola County the State Highway Engineer is hereby directed to revise plans and specifications on State Highway #8, from Murvaul Creek to the Shelby County line so as to bring the cost of construction, if practicable, to \$8,000.00 per mile or less, and to advertise for bids at the October meeting of the Commission.

In Tyler County it is ordered by the Commission that the State Highway Engineer advertise for bids for the construction of a bridge across Neches River, near Rockland, State Highway #40, for the October meeting. - In Brazos County it is ordered by the State Highway Commission 3216. that the State Highway Engineer advertise for bids at the November meeting for the construction of grading and drainage structures and paving on State Highway #90, from the Navasota River to the Brazos Bridge.

In Jasper County it is ordered by the Commission that the State Highway Department will pay two-thirds of the cost of a 20 ft. concrete pavement through the City of Jasper, on State Highway #8, #63, and #45, approximately 4.5 miles, on condition that the City of Jasper and Road District #2 will contribute one-third of the cost of said 20 ft. concrete pavement and will extend the pavement at such points as the State Highway Engineer may designate to a distance of at least 32 ft. A.F.E. 30-411.
- 3219. In Lee County the Maintenance Department is authorized by the Commission to proceed with the improvement of approximately five miles of State Highway #20 west of the town of Giddings, eliminating two railroad grade crossings, conditioned that Lee County will secure right-of-way.
  - In Lee County the State Highway Engineer is authorized to instruct the Maintenance Department to set fences back on all of State Highway #20. where the right-of-way has been secured and to employ local labor to do this work if possible.

In Gonzales County the State Highway Engineer is instructed to revise estimates heretofore made for graveling State Highway #29 from Gonzales to the Gonzales-Caldwell County line, and when this has been done and County has furnished gravel and additional right-of-way, to report to the Commission for further action.

It is ordered by the Commission that the Executive Committee of the American Association of State Highway Officials be requested to extend U. S. Highway #77, from Dallas, in Dallas County, by way of Highway #40 to Jacksonville, in Cherokee County, to connect with U. S. Highway #271; and to re-route U. S. Highway #271 from Zavalla, in Angelina County, by way of Rockland, in Tyler County, to Village Mills, Kountze and Voth, in Hardin County, to Beaumont, in Jefferson County.

3223.

In San Jacinto County it is ordered by the Commission that Highway #45 heretofore designated from Shepherd by way of Cold Springs is hereby redesignated so that Point Blank be made a control point and the intersection of the two highways.

3224.

In <u>Matagorda</u> County the State Highway Engineer is authorized to advertise for bids for the construction of grading and drainage structures on State Highway #57 from Jackson-Matagorda County line to a connection with State Highway #58, provided that if the State Highway Department is not in funds at that time Matagorda County will advance all of the cost of Unit I construction and will be credited for the State's part advanced in the construction of Unit II.

3225.

In Matagorda County the State Highway Engineer is authorized to advertise for bids for the construction of a spur from the town of Mark-ham to State Highway #57, a distance of approximately 3800 ft. with the understanding that the State Highway Department will be relieved of main-tenance on this in the future.

3226.

In Ochiltree County the State Highway Department agrees to pay two-thirds of cost of an 18 ft. pavement on streets traversed by State Highway #4, and one-half of cost of an 18 ft. pavement on streets traversed by State Highway #117 in the town of Perryton, on condition that a satisfactory type of pavement is approved by the State Highway Engineer. The State Highway Department will be relieved of maintenance on said highways inside of the city limits of Perryton and the City Council of Perryton agrees to enforce any traffic regulations that may be required by the State Highway Department with reference to parallel parking in congested areas. The State Highway Engineer is hereby instructed to prepare estimate of cost of such construction. A.F.E. 30-212.

3227.

In <u>Dallas</u> County on bids received September 16, 1930, contract for construction of grading and drainage structures from Long Creek to the Scyene Road, a distance of 2.312 miles, on State Highway #15-A, S.P. 946-A, is awarded to R. B. Holifield, Dallas, Texas, for \$47,932.78, which is the lowest and best bid.

3228.

In Throckmorton County on bids received September 16, 1930, contract for construction of triple asphalt surface treatment from Throckmorton to the Baylor County line, a distance of 15.424 miles, on State Highway #23, S.P. 675-B, Unit III, is awarded to J. E. Ward Company Dallas, Texas, for \$52,517.87, which is the lowest and best bid.

3229.

In <u>Hall</u> County on bids received September 16, 1930, contract for construction of grading, drainage structures and triple bituminous surface treatment from the Briscoe County line to Turkey, a distance of 3.186 miles, on State Highway #86, S.P. 478-A; is awarded to McClung Construction Company, Fort Worth, Texas, for \$42,473.21, which is the lowest and best bid.

In <u>Hansford</u> County on bids received September 16, 1930, contract for construction of grading and drainage structures from the Hutchinson County line to the Ochiltree County line, a distance of 19.682 miles, on State Highway #117, S.P. 925-C, is awarded to Asplund Construction Company, Amerillo, Texas, for \$24,050.50, which is the lowest and best bid.

3231.

In <u>Fisher</u> County on bids received September 16, 1930, contract for construction of grading and drainage structures from a point 1.33 miles east of Roby to the Jones County line, a distance of 12.271 miles, on State Highway #83, S.P. 917-B, is awarded to Huddleston & Work, Crosbyton, Texas, for \$48,428.89, which is the lowest and best bid.

3232.

In <u>Refugio</u> County on bids received September 16, 1930, contract for construction of grading and small drainage structures from a point three miles Northeast of Refugio, to State Highway #113 near the Victoria County line, a distance of 19.197 miles, on State Highway #128, S.P. 840-is awarded to E. G. Powell, Jacksonville, Texas, for \$87,540.29; and the contract for the large structures is awarded to Edwin Artmann, Giddings, Texas, for \$51,416.28, which are the lowest and best bids.

3233.

In <u>Carson</u> County on bids received September 16, 1930, contract for construction of grading and drainage structures from a point near Conway to the Potter County line, a distance of 9,921 miles, on State Highway #75, S.P. 767-C, is awarded to Field Bros. & McCelvey, Lubbock, Texas, for \$14,906.02, which is the lowest and best bid.

In Bowie County on bids received September 16, 1930, contract for construction of double bituminous surface treatment on gravel base course with limestone binder from a point approximately one mile south of Texas & Pacific Railroad Crossing at New Boston to a connection with Highway #1 at Corley, a distance of 8.354 miles, on State Highway #8, Job M-1-B-4, is awarded to Cocke & Braden, Marshall, Texas, for \$66,860.90, which is the lowest and best bid.

In <u>Jackson</u> County it is ordered by the Commission that State Highway #111 from Edna north to the <u>Lavaca</u> County line will not be constructed until provision is made for construction of said highway in <u>Lavaca</u> County

3239.

In <u>Jackson</u> County it is ordered by the Commission that the town Francitas shall be made a control point on State Highway #58, making a connection at that point with State Highway #58.

3240.

In Anderson County it is ordered by the Commission that County put in escrow with the State Highway Department the sum of \$52,000.00, being balance of County's funds for construction of State Highways, which sum of \$52,000.00 is to be used for the construction of 8.5 miles of State Highway #43, from Palestine south.

3241.

In Nacogdoches County it is ordered by the Commission that 1.25 miles of State Highway #110 from Sacul to the Cherokee County line be taken over for maintenance and that the State Highway Engineer investigate and report to the Commission what maintenance is needed.

3242.

In Red River County an initial appropriation of \$65,000.00 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Maintenance Division on State Highway #66, from Bogota northeast and Clarksville southwest, a distance of approximately 12 miles; this appropriation being made for betterment work, Job M-1-T-4 for widening shoulders and ditches and regraveling. This appropriation is made on condition that said county will furnish such right-of-way as may be required to be not less than 100 feet in width, fencing to be done by the County. Motion made and seconded that an additional preliminary engineering appropriation be made in the amount of \$125.00 (\$50.00 per mile) on that section of Highway #1 from end of F.A.P. 171 to Wellington Street in Greenville, a distance of 2.5 miles in Hunt County. This additional appropriation is made in order that the plans may be completed and the project placed under contract as the original appropriation is nearing exhaustion. A.F.E. 30-416.

In <u>Hopkins</u> County, advice having been given of temporary injunction against the county placing their money on that portion of State High way #37, so uth of Sulphur Springs, and it having come to the attention of the Commission that Hopkins County has secured the right-of-way from this point, it is hereby ordered that work shall proceed on this project and the State will advance the estimates until litigation has been concluded. The State Highway Engineer is further instructed to proceed with condemnation proceedings to secure the right-of-way in question near Sulphur Springs, and to charge the cost of same to the county when and in the event the litigation is settled in the county's favor.

3249.

In <u>Erath</u> County an increase appropriation of \$5,000.00 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Maintenance Division on State Highway #68, from Somer vell-Erath County line to Stephenville, a distance of 18.323 miles; this appropriation being made for betterment work, Job M-2-G-3, for placing additional caliche on impassable sections, which brings the total appropriation for maintenance job M-2-G-3 authorized in this County for the fiscal year to \$10,000.00. A.F.E. 30-417.

3250.

In <u>Tarrent</u> County an initial appropriation of \$90,000.00 Federal Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #2, F.A.P. 473-A from M.K. & T. Railroad to Johnson County line, a distance of 7.736 miles, for the construction of concrete pavement on condition that said said county will furnish 100% for such improvement and such right-of-way as may be required to be not less than 100 ft. in width, fencing to be done by the Gaunty; and with the further understanding that said county will be reimbursed or credited with State's share of cost when State funds become available as set forth in Minute #3088. A.F.E. 30-418.

3251.

In <u>Tarrant</u> County an initial appropriation of \$17,000.00 Federal Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #10, F.A.P. 591-D, for the construction of Big Bear and Big Fossil Creek Bridge on condition that said county will furnish \$21,181.34 for such improvement and such right-of-way as may be required to be not less than 100 ft. in width, fencing to be done by the County; and with the further understanding that should the cost of improvement exceed the foregoing estimate, Tarrant County shall furnish its proportionate share of the additional cost. In <u>Tarrant</u> County an initial appropriation of \$36,500.00 Federal Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #100, F. A.P. 591-C, from Junction with Highway #121 north through Keller, a distance of 9.675 miles for the construction of grading and drainage structures on condition that said county will furnish 100% for such improvement and such right-of-way as may be required to be not less than 100 ft. in width, fencing to be done by the County; and with the further understanding that said county will be reimbursed or credited with State's pro-rate part when State's funds become available as set forth in Minute #3089. In <u>Tarrant</u> County an initial appropriation of \$51,227.77 State Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #114, S.P. 839-D-II, from Dallas County line to 1.94 miles west a distance of 1.94 miles for the construction of concrete pavement. A.F.E. 30-421.

3254.

In Childress County an increase appropriation of \$7,540.32 State and Federal Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #4, F.A.P. 573-A, from Childress to Red River, a distance of 9.264 miles, for the construction of grading and drainage structures making a total of \$63,692.62 State and Federal Funds advanced to Childress County to cover this construction and the understanding that before Unit II is built Childress County will place their share of funds to the credit of this project and the State will take this credit for funds advanced; this \$7,540.32 additional appropriation is necessary to pay final estimate and is in addition appropriation made in Minute #2285 which is hereby reconfirmed. In Childress County an initial appropriation of \$140,000.00 Federal Funds is hereby made to be expended under the direction of the State Highway Engineer through the Construction Division on State Highway #5, F.A.P. 438-I from Hale County line to connection with #4, a distance of 13.455 miles for the construction of concrete pavement, on condition that said county will furnish 100% for such improvement, and such right-of-way as may be required, fencing to be done by the County; and with the further understanding that Childress County will be reimbursed or credited with States share of cost of which State funds become available as set forth in Minute #3098. A.F.E. 30-423.

3256.

In <u>Cottle</u> County on Highway #28, F.A.P. 536-A, Unit II, extending from Paducah to a point 4.199 miles northeast a distance of 4.199 miles, the State Highway Engineer is hereby authorized to proceed with the construction of concrete pavement on condition that Cottle County shall pay the entire cost of construction and furnish such right-of-way as may be required, fencing to be done by County, and that when State Funds are available Cottle County shall be reimbursed or credited with two-thirds of the actual cost of construction.

3257.

In <u>Throckmorton</u> County on Highway #23, S.P. 675-B, Unit III, extending from Throckmorton to the Baylor County line, a distance of 15.424 miles, the State Highway Engineer is hereby authorized to proceed with the construction of triple asphalt surface treatment on condition that Throckmorton County shall pay the entire cost of construction and furnish such right-of-way as may be required, fencing to be done by the County, and that when State Funds are available Throckmorton County shall be reimbursed or credited with two-thirds of the actual cost of construction.
