In Angelina County, it is ordered by the Commission that an appropriation of \$12,420.00 be made to cover the cost of scarifying and blading out the present old asphalt surface on Highway No. 35, adding approximately 10 cubic yards of iron ore gravel per station, and surface mixing this gravel with approximately 0.5 gallon of asphalt per square yard, 18 feet wide, from Burke to 1.8 miles South of Lufkin, a distance of 5.8 miles. This work is to be done under the direction of the State Highway Engineer through the Maintenance Division as a Special Maintenance Job, but contract is to be advertised and awarded for the placing of the gravel.

WHEREAS, in Brewster County, the Highway from Marathon through the Big Bend State Park into Terlingua and thence to Santa Helena Canyon on the Rio Grande River was recently designated as a State Highway, and by Minute No. 12126, an appropriation of \$31,400.00 was made to place this road in condition so that it could be maintained; and

WHEREAS, this money has been expended in widening narrow side hill cuts, repairing bridges, building overflow sections, erecting signs and similar work, and this entire road put in a fair condition for maintenance except after very heavy rains, except for the section from a point about 8.6 miles east of Terlingua through Terlingua to a point about 9.4 miles south of Terlingua, which is impassable after very ordinary rains, because this section of road crosses Terlingua Creek twice on overflow sections; and

WHEREAS, there now exists a road connecting the highway from a point about 8.6 miles east of Terlingua to 9.4 miles south of Terlingua which does not cross Terlingua Creek and which can be placed in about the same condition as the present road with regular maintenance funds available, thereby changing the distance into Santa Helena Canyon by about 9 miles in making a more nearly all weather route:

IT IS THEREFORE ORDERED BY THE COMMISSION, that that section of Highway  $^{\rm No}$ . 227 from Terlingua south 9.4 miles be cancelled and that this highway be designated over route from a point about 8.6 miles east of Terlingua into Terlingua being designated as a spur and maintained as a part of the State Highway System.

In Brooks County, it is ordered by the Commission that an appropriation of \$10,161.90 be made to cover the cost of remixing and reclaiming 3,000 tons of old salvaged rock asphalt now in stock piles along Highway No. 66, and with this material to place a new wearing surface on that section of Highway No. 66 extending from the Hidalgo County line to the end of the concrete pavement at Encino, a distance of 11.748 miles. In Cooke County, an increased appropriation of \$2,612.00 is hereby made for the completion of bridge and approaches on Control 312-1-2, Highway No. 89. This overrun in cost is caused by increased quantities of special and rock road excavation due to necessary reclassification on construction.

In Floyd County, it is ordered by the Commission that, in accordance with Minute No. 1070, whereby a highway was designated from Post, in Garza County, to Floydada, in Floyd County, conditioned that this road be taken over for maintenance when constructed; that section of this highway from Floydada to Crosby County line recently improved as an NRWR Project, be taken over for maintenance; and an appropriation of \$4,795.20 is hereby made to cover the cost of maintaining this 19.98 miles section for the balance of this fiscal year.

S. 290, extending from Fredericksburg to the Kimble-Gillespie County line, a distance of approximately 25.5 miles, at a total estimated cost of \$320,000, State and Federal funds; and the State Highway Engineer is directed to submit a request to the U. It is, therefore, ordered by the Commission that this project be permanently suspended and that such part of the originally allocated funds as necessary be authorized for payment of work which has been done.

In <u>Gray County</u>, Highway No. 152, N.R.W.R. 5, Section 3, the Division Engineer recommends that because of limited W.P.A. labor, additional funds are needed to complete, with six months, this project of reshaping the roadway section and placing caliche base extending from the east county line west for a distance of 11.779 miles.

It is therefore ordered by the Commission that \$6,000.00 State funds be appropriated to supplement P.W.A. and W.P.A. funds.

## A.F.E. 37-470

In <u>Gregg County</u>, it is ordered by the Commission that an appropriation of \$1,783.35 be made to cover the cost of Roadway Maintenance on that section of Highway No. 176 extending from near junction Highway 135 to junction Highway 26 north of Kilgore, a distance of 3.963 miles, for the balance of the fiscal year, and the State Highway Engineer is instructed to take this section of road over for maintenance, inasmuch as all conditions imposed in this designation have been complied with.

In Hansford County, Highway 88, N.R.W.R. 11, Section 1, it appears that sufficient W.P.A. labor is available to justify completion of the remaining two mile gap. Due to the shortage of W.P.A. participation, additional State funds are needed.

It is, therefore, ordered by the Commission that \$2,000.00 State funds be appropriated to supplement P.W.A. and W.P.A. funds.

In Hardeman County, it is ordered by the Commission that an appropriation of \$525 be made to cover the cost of purchasing from Mr. J. E. Wiley Lots No. 13 to No. 21 inclusive in Block  $^{\rm N}$ o. 341 in Quanah for a warehouse site.

In Karnes, Bee and Live Oak Counties, it is ordered by the Commission that a State Highway be designated from Kenedy, in Karnes County, to Three Rivers, in Live Oak County, with the condition that those sections of this highway in Bee and Live Oak Counties not be taken over for maintenance until right-of-way is furnished by the County and the road constructed; but that maintenance be assumed by the State Highway Department on that section from Kenedy to the Bee County line, an approximate distance of 11.2 miles, which has already been improved by Karnes County. An appropriation of \$3,920.00 is hereby made to cover the cost of maintenance for the balance of this fiscal year.

In San Saba County, it is ordered by the Commission that an appropriation of \$950.00 be made to cover the cost of placing an asphaltic dust preventive 22 feet wide on the 2,800 foot section of Highway No. 81 from the end of the pavement in the south edge of San Saba south in order to eliminate the dust nuisance on this section of road. This work is to be done under the direction of the State Highway Engineer through the Maintenance Division.
