Hill County, Control 121-3-9, Ernest Loyd, Contractor, providing for the construction of spur roads into Mertens and Brandon, funds for which were appropriated under Minute No. 14412, dated November 23rd, 1937.

In Angelina County, it is ordered by the Commission that an appropriation of \$513 be made to cover the cost of vented gas steam radiators to be installed in the Division Office Building at Lufkin, and an appropriation of \$622 be made to cover the cost of installing vent pipes so that all gas fumes will be carried outside the building. This work is to be done under the direction of the State Highway Engineer through the Maintenance Division.

In Fort Bend County, it is ordered by the Commission that an increase of \$1,512.32 be made to the appropriation of \$11,478.59 previous ly made by Minute No. 13985 to cover the cost of stabilizing with cement a 20 inch section next to the 18 foot pavement on Highway No. 3 from the East City Limits of Rosenberg to 1.5 miles West of Sugarland, a distance of 7.746 miles, this work being done under the direction of the State Highway Engineer through the Maintenance Division.

It is, therefore, ordered by the Commission that NRWR 158, Section 1, be reinstated to permit the completion of the originally proposed project, conditioned upon sufficient relief labor being available, and that \$50,000.00 State funds be appropriated to supplement Works Progress Administration funds, it being understood that P.W.A. funds, as they accrue, will be applied to this project, not to exceed 30% of the material and labor cost.

In Jasper County, it is ordered by the Commission that a spur, approximately .58 mile in length, connecting Highway No. 8 to the North end of Main Street, in the City of Jasper, be designated as a part of the Highway System; and

That a spur, approximately .51 mile in length, connecting High-way No. 8 to the South end of Main Street, in the City of Jasper, be designated as a part of the Highway System.

An appropriation of Eighteen Hundred Dollars (\$1,800.00) is hereby made to do the work, which is to be done through the Maintenance Division.

It is further ordered that when the work, as above designated on the two spurs mentioned above, is completed, said spurs shall be transferred to the City of Jasper for maintenance, and no maintenance of the completed spurs shall be performed by the State Highway Department.

In Jefferson County, right-of-way was secured, and by Minute No. 14337 curved connecting roads were authorized for construction at the intersection of Highway No. 8 and Nederland Spur. Whereas, the consideration for original tract was Three Hundred Eighteen (\$318.00) Dollars and was paid by Lee County.

It is, therefore, ordered by the Commission that the Governor be requested to execute a deed reconveying to Herman Bittner et ux four (4) parcels of land not now needed by the State, on condition that Herman Bittner will execute a deed conveying to the State eight (8) parcels of land desired by the State and without additional cost to it.

In Leon County, it is ordered by the Commission that an appropriation of \$3,146.00 be made to cover the cost of replacing felloe guard and hand rail on eight timber structures on Highway No. 32 between Buffalo and the Madison County line, these structures totaling 2079' in length. This work is to be done under the direction of the State Highway Engineer with Maintenance Forces.

S. Soil Conservation Service, the estimated cost for that part of the work being \$4,390.74. That part of the work to be done by the Department is to be done under the direction of the State Highway Engineer through the Maintenance Division with Maintenance Forces.
