This action is taken in order to provide for the most needed work of this character as demanded by proper maintenance in this District.

16199

As a matter of program clarification, and in order to provide for proper construction sequence, it is ordered that the 1939 and 1940 Regular Federal Aid Programs be modified as follows, and the State Highway Engineer is directed to submit requests to the U. S. Bureau of Public Roads providing for these proposed program adjustments:

In Parker County, it is ordered that the 1939 Regular Federal Aid Program project providing for grading and drainage structures on

State Highway 1, U. S. Highway 80, extending from the Tarrant County line to Weatherford, a distance of approximately 14.5 miles at a total estimated cost of \$270,000 be modified to provide for grading, drainage structures, and roadbed treatment over the same length and between the same limits at a total estimated cost of \$566,000. It is further ordered that overlapping projects be withdrawn from the 1940 Regular Federal Aid Program providing for grading, drainage structures, and road bed treatment on U. S. Highway 80 extending from Clear Fork to Pythian Home, a distance of 6.2 miles, at a total estimated cost of \$142,000, and extending from Pythian Home to Weatherford, a distance of 1.7 miles, at a total estimated cost of \$50,000.

In Tarrant County, it is ordered that the 1939 Regular Federal Aid Program be modified to withdraw the project providing for grading and drainage structures on State Highway 1, U. S. Highway 80, extending from State Highway 10 to the Parker County line, a distance of 6.2 miles, at a total estimated cost of \$90,000. It is further ordered that the 1940 Regular Federal Aid Program item which provides for grading, drainage structures and roadbed treatment, on U. S. Highway 80, extending from U. S. Highway 377 to west of Mary's Creek, a distance of 4.5 miles, at a total estimated cost of \$157,000 be modified to provide for grading and drainage structures on U. S. Highway 80 extending from U. S. Highway 377 to the Parker County line, adistance of approximately 6.2 miles, at a total estimated cost of \$130,000.

In Rusk County, it is ordered that 'the 1939 Regular Federal Aid Program be modified to withdraw the project providing for grading and drainage structures on State Highways 43 and 64 in Henderson, at a total estimated cost of \$45,000. It is further ordered that the 1940 Regular Federal Aid Program item which provides for grading and drainage structures on State Highway 64 extending from Henderson to near Joiner-ville a distance of 6.0 miles at a total estimated cost of \$90,000 be enlarged to provide for grading and drainage structures on Highway 64 extending from near Joinerville easterly to a point east of Henderson a distance of approximately 7.5 miles at a total estimated cost of \$135,000.

In <u>Wichita County</u>, it is ordered that the 1939 Regular Federal Aid Program be modified to withdraw the project providing for grading and drainage structures on State Highway 5, U. S. Highway 370 extending from 7.0 miles west of Iowa Park east through Iowa Park a distance of 7.8 miles at a total estimated cost of \$68,000. It is further ordered that the 1940 Regular Federal Aid rogram item which provides for surfacing of this same project, at a total estimated cost of \$140,000, be enlarged to provide for grading, drainage structures and surfacing at a total estimated cost of \$208,000.

In order to provide funds for unavoidable overruns, to eliminate items otherwise provided for, and to assist in the distribution of funds by Counties for the several Programs as required by the U.S. Bureau of Public Roads, it is ordered that the 1938, 1939 and 1940 Secondary Highway Programs, and the 1939 State Program be modified as follows, and the State Highway Engineer is directed to submit requests to the U.S. Bureau of Public Roads providing for the modifications of the Federal Programs.

Eliminate surfacing from the approved item in Rusk County under the 1938 Secondary Highway Program extending along feeder road from the Brachfield-Dotson Road to the Panola County line, a distance of 0.7 mile releasing \$2,000 State and Federal Funds. Addition of this item to the 1940 Secondary Highway Program - all description remaining the same with exception that the total cost becomes \$5,000, 50% being Federal funds.

Eliminate the item in Lamar, Delta and Hopkins Counties under the 1939 Secondary Highway Program providing for grading and drainage structures on Feeder road extending from near Cunningham south across North and South Sulphur Rivers to near Sulphur Bluff, a distance of approximately 4.0 miles, at a total estimated cost of \$160,000, 50%

being Federal Funds. Addition of this item to the 1940 Secondary Highway Program - description remaining the same except that the type is increased to include grading, drainage structures, and roadbed treatment, and the total estimated cost is increased to \$312,000, 50% being Federal Funds. This modification will eliminate the three items of the 1940 Secondary Highway Program in the same Counties, and on the same road which provided for surfacing, a total distance of 7.1 miles, at a total cost of \$71,000, 50% being Federal Funds.

Advance the 1940 Secondary Highway Program item in Culberson County providing for grading and drainage structures on Highway 54 extending from Van Horn north, a distance of approximately 5.5 miles, at a total estimated cost of \$45,000, 50% being Federal Funds to the 1939 Secondary Highway Program - all portions of the item description to remain the same.

Advance the 1940 Secondary Highway Program item in Cooke County which provides for grading, drainage structures, and surfacing on feeder road extending from 8.0 miles southwest of Gainesville to near Era, a distance of approximately 4.2 miles, at a total estimated cost of \$60,000 50% being Federal Funds to the 1939 Secondary Highway Program - all portions of the item description to remain the same.

Advance the 1940 Secondary Highway Program item in Matagorda County which provides for the construction of grading and drainage structures on Feeder road extending from the Brazoria County line to Pledger, a distance of 5.7 miles, at a total estimated cost of \$52,000, 50% being Federal Funds, to the 1939 Secondary Highway Program - all portions of the item description to remain the same.

Eliminate the 1939 Secondary Highway Program item in Zapata County which provided for a bridge and approaches over the Valeno Creek approximately 12.0 miles northeast of Zapata on the Zapata-Hebbronville feeder road, at a total estimated cost of \$20,000, 50% being Federal Funds. This item is eliminated since the County has built a bridge at this location subsequent to the programing of this item.

Eliminate the 1940 Secondary Highway Program item in Sherman County which provides for surfacing of Highway 9 extending from 5.0 miles south of Stratford south, a distance of approximately 14.5 miles, at a total estimated cost of \$88,000, 50% being Federal Funds. Addition of this item to the 1939 State Program - all portions of the item description to remain the same except that the entire cost will be financed with State Funds.

Eliminate the 1939 State Program item in Bexar County which provides for grading, drainage structures, and surfacing on State Highway 16 extending from San Antonio to the Callaghan Road, a distance of approximately 3.2 miles, at a total estimated cost of \$68,000. This item is eliminated since it nowappears that right-of-way cannot be secured.
