- Motion by Mr. Johnson, seconded by Mr. Ely, that San Jacinto County be authorized, out of its own funds, to construct drainage structures and to grade approaches thereto on Highway No. 45-A, from Cold Springs to Old Waverly, this work to be done under the supervision and direction and on a location approved by the State Highway Engineer, together with plans and specifications, and that the road over the new structures and over the present grade at other points be maintained by the State after structures and approaches have been built, with the understanding that San Jacinto County will be given credit for the amount of funds so expended by it when said highway is permanently improved, and that the State Highway Engineer be instructed to advertise for bids. Motion carried.
- 2. (a) Motion by Mr. Johnson, seconded by Mr. Ely, that the State High-way Engineer be directed to take the matter up with the Bureau of Public Roads of making a direct location from about two miles west of Rock Creek direct to Sweet Home on Highway No. 72, in Lavaca County, on the most practical route; then, if that cannot be done, that the interested parties appear before the Commission and present the matter of extending State Aid on the project. Motion carried.
- (b) Motion by Mr. Johnson, seconded by Judge Ely, that the sum of \$61,000.00 be appropriated to Lavaca County for topping with asphalt, Highway No. 72, F.A.P. 373-B, Unit II, approximately 14 miles, one-half State Aid and one-half Federal Aid, it being understood that the County has already contributed at least fifty percent to the cost of said road. Motion carried.
- 4. Motion by Mr. Ely, seconded by Mr. Johnson, that the State Highway Engineer be authorized to advertise for bids for the grading and drainage structures on Highway No. 21, from Crockett approximately 8.547 miles east for which an allotment is made in the amount of \$34,603.22, on the condition that Road District No. 3 will pay one-third the cost of such construction. Motion carried. This is in Houston County.
- Motion by Judge Ely, seconded by Mr. Johnson, that the State Highway Engineer be authorized to advertise for bids for the construction of a concrete road, approximately five miles, on Highway No. 28, from Oklaunion to the Red River, in Wilbarger County, on condition that Wilbarger County will put up fifty percent of the cost of such construction, the estimated cost being \$152,828.68. Motion carried.
- Motion by Mr. Johnson, seconded by Mr. Ely, that an allotment of approximately \$175,000.00 be made to Grayson County for the construction of grading and drainage structures on Highway No. 6, from the Collin County line to the Red River Bridge, and on Highway No. 91, from Denison to the Red River at Preston's Bend, one-third State Aid, one-third Federal aid and one-third County aid. Location, plans and specifications to be approved by the State Highway Engineer, who is authorized to advertise for bids as soon as the location, plans and specifications are ready, on condition that Grayson County furnish 100 ft. right-of-way. Motion carried.

Motion by Mr. Johnson, seconded by Mr. Ely, that an allotment of approximately \$255,041.60 be made to Leon County for the construction of grading and drainage structures on Highway No. 32 from the Madison County line to the Freestone County line, a distance of approximately 30 miles, one-third State Aid, one-third Federal Aid, one-third County Aid; said construction to be on location, plans and specifications approved by the State Highway Engineer, on condition that Leon County will furnish 100 ft. right-of-way; and the State Highway Engineer is hereby authorized to advertise for bids on this project. Motion carried.

- Motion by Mr. Johnson, seconded by Judge Ely, that contract for construction of a concrete bridge over the Pease River, on State Highway No. 5, in Wilbarger County, F.A.P. 524-B, be awarded to J. W. Williams of Oklahoma City, Oklahoma, for \$130,197.10, same being the lowest and best bid, and this award is concurred in by Mr. John B. Nabers, County Engineer of Wilbarger County and Mr. P. H. Everett, Highway Engineer, Bureau of Public Roads. Motion carried.
- Motion by Mr. Johnson, seconded by Mr. Ely, that an allotment of approximately \$90,000.00 be made to Limestone County for concrete pavement on Highway No. 7, from the Freestone County line west to the corporate limits of Mexia, a distance of approximately 3 miles, one-third State Aid, one-third Federal Aid, one-third County Aid, on location, plans and specifications to be approved by the State Highway Engineer, and that the State Highway Engineer be authorized to advertise for bids on this project, on condition that the County furnish 100 ft. right-of-way. Motion carried.
- Motion by Mr. Johnson, seconded by Mr. Ely, that \$60,000.00 approximately, be appropriated to Madison County for the construction of grading and drainage structures on Highway No. 21, from North Zulch to the Navasota River, at Holly Bend, a distance of approximately 6.5 miles, one-third Federal Aid, one-third State Aid and one-third County Aid, on location, plans and specifications to be approved by the State Highway Engineer, on condition that said work of construction shall not actually be undertaken until and unless Madison County shall be in funds to bear its share of the cost of the bridge and approaches across the Navasota River. Motion carried.
- Motion by Mr. Johnson, seconded by Judge Ely, that a State Highway be designated from Beaumont in <u>Jefferson</u> County via Winnie, Stowell, and Anahuac in <u>Chambers</u> County to be known as Highway No.125. Motion carried.
